These estate gifts led to the establishment of two lecture series: The Vince Howard Memorial Lecture and the James P. '60 and Mary Clare Sczepaniak Lecture.

Vince Howard, a beloved and respected History professor, served as the first African-American department chair at Lewis. Throughout his

extraordinary academic career, Vince imbued so many of our students with a deep and abiding passion for the study of history. It is very meaningful to the Lewis community that Vince designated funds for the University in his will which, upon his passing

in 1989, were used to establish a popular annual history lecture. His amazing foresight has allowed the University, for decades now, to bring notable expertise to our campus and encourage students to engage in inspiring and thought-provoking discussions.

James (Jim) Sczepaniak '60 was also involved in education his entire professional career and spent many years teaching history at Romeoville High School. He was particularly passionate about exploring and preserving the rich and varied history of the Romeoville and Joliet area. It is thus only fitting that the recently launched James P. '60 and Mary Clare Sczepaniak Lecture Series, which was established with a portion of a generous gift from Jim's estate, will now bring prominent and nationally-recognized academic leaders to Lewis to examine our local and regional history within a national context.

# Your Will—Your Way

When it comes to writing your will, you can choose how—and to whom—you want your assets distributed after you are gone. The will is an extremely flexible instrument and there are a number of ways that you can designate your loved ones and charitable organizations to receive gifts.

**Give "what's left."** The residue of your estate is what remains after all other distributions have been made. After first providing for loved ones, you can devote all or a portion of the residue of your estate to Lewis University.

**Give adjustable amounts.** Leaving designated percentages of your estate allows you to give proportions rather than specific amounts. The amounts received are then automatically adjusted as the value of your estate changes.

**Leave a fixed amount.** Your will can specify a dollar amount to be given to Lewis University. This

option can make sense if you would like to ensure that a certain amount is received before leaving any remaining assets to others. Remember, however, that your financial situation may change over time. It is important to review your will and other plans from time to time. (See Page 4 for more details.)

Wills offer flexibility. You can also combine these methods in your will. For example, you might specify that certain amounts or properties go to certain people, then divide the remainder by percentages among Lewis University and other charitable organizations close to your heart.
